## Validation/Landmark Cases

- **Record Setting Traumatic Brain Injury Case \$22,650,000 million**  
Ted Bassett represented a young woman hit by a drunk driver who was on his way home from a local bar. The young girl sustained permanent brain damage with memory loss and cognitive deficits. The defendant was sentenced to eight to ten years in jail. Ted sued the drunk driver and the six bars where he drank before the accident. Ted obtained a judgment totaling \$22.65 million—which was reported to be the largest personal injury judgment in Worcester County, Massachusetts.
- **Premises Liability Accident Results in \$2,200,000 Settlement**  
Ted Bassett successfully prosecuted a case against a landlord who negligently failed to inspect the sliding glass doors in a second floor apartment.
- **Victim of Drunk Driving Accident Awarded \$2,000,000**  
Ted Bassett also obtained a judgment in the Worcester Superior Court for \$2,049,867.00 for the victim of a drunk driving accident.
- **Interstate Truck Accident Results in \$2,000,000 Settlement**

Ted Bassett secured a \$2.1 million settlement for a client injured when a Canadian Trucking Company failed to properly secure a cargo of lumber. It was later discovered that the truck driver was fatigued and had falsified his logbook.

- **Motorcycle Driver Recovers \$900,000**

Ted Bassett settled a personal injury case for a motorcycle driver even though the police reconstruction team concluded that the motorcycle had crossed over the center line. Ted assembled an accident reconstruction team which proved that other vehicle crossed the center line.

## **Bicycle Accidents**

### **Bicycle Accident Injuries are Very Serious**

Injuries from bicycle accidents occur more often than one might think. When these accidents happen, the injuries are typically very serious, even death since a cyclist does not have the protection that a car or truck provides. Many times, these accidents include intoxication since the misnomer is that a bicycle rider believes that the laws concerning operating under the influence of alcohol only apply to motor vehicle operators. That is simply not the case.

While an injury victim will generally have three (3) years to file a lawsuit after being injured in a bicycle accident, we can gain significant advantage by getting involved early and doing the necessary due diligence to manage the case and obtain the best possible outcome for our clients.

## **Slip and Fall**

### **Who is Responsible for a Slip and Fall Accident?**

When a person or company owns a property, they have an obligation to make sure that premises is safe for all visitors. For example, stairways must have handrails, floors should be free of unreasonable tripping or spilling hazards, and property owners should warn visitors of anything

dangerous on the property. If you have been injured in a slip and fall accident, you may be entitled to remedies if injured due to an owner's negligence.

Often, premises liability claims are not limited to just the owners; the business that operates on that premises is also responsible for ensuring the property is safe. In addition, any company performing work on a property must make sure they leave the property in safe condition, even during construction.

## **Product Liability**

### **Safety First**

Sadly, people are injured every day as a result of defective products. As consumers, we have a reasonable expectation that these products will be safe. When products are not safe, people are in danger of serious injury or death. Defective products not only diminish the trust we have for certain brands, but they also expose us to the possibility of horrific injuries.

The three main categories of product liability cases are manufacturing defects, design defects, and insufficient instructions or warnings.

### **Keep the Product**

It can be very difficult to make a product liability case without access to the product.

If you have been injured as a result of a product defect, you should first attempt to save the product, assuming this can be done safely. Many times, an injury happens when a product is in someone else's hands or company; in those cases, it is even more critical to contact a product liability attorney right away, as we will ensure that the product is maintained.

## Making a Claim

Health insurance will not pay medical bills when an injury occurs at work. Workers compensation insurance will pay medical bills and any lost wages that result from the injury, so in many cases an injured worker has no choice but to file a workers compensation claim. While workers compensation is helpful, it only covers a portion of your salary.

## Who is Responsible?

In many cases, an experienced construction accident attorney will be able to file a case against another contractor who was on the site and was responsible for safety. It is the job of a general contractor to make sure sites are safe. Beyond that, every subcontractor has a job to do on a jobsite, and if they do not do it safely, an injured person may have a claim against that contractor.

## **Liquor Liability**

### **Who is Responsible?**

Each year, thousands of innocent people are injured or killed by drunk drivers. In Massachusetts, if a bartender or waitress continues to serve drinks to someone who is obviously drunk and that person then gets in their car and causes an accident, the drunk driver and the bar or restaurant can be found jointly responsible for injuries.

Many of the drunk driving cases we have handled at Mirick have involved death, brain damage or permanently disabling physical injuries.

### **Building Your Case**

Cases against bars and restaurants are difficult cases because there needs to be evidence that the bartender knew or should have known that the customer was intoxicated when the customer was served their last drink. At Mirick, we have developed relationships with pharmacologists and toxicologists who can review the police reports, hospital records and blood alcohol test results to determine whether these drunk drivers would have been showing signs of intoxication at the time they were served their last drink. These experts carefully analyze the number of drinks served, the types of drinks served, the time period over which the drinks were consumed, the height, weight and amount of food ingested along with the alcohol. Based on all of this information, scientific evidence can be presented to establish that the bartender should have known they were serving an individual who was already intoxicated.

### **Timing is Critical**

If you have been injured by a drunk driver you need to retain an attorney immediately to determine if there is a potential case against the bar or restaurant.

## Wrongful Death

### Holding Wrongdoers Responsible

There is no more devastating event in a person's life than hearing a family member has been taken too soon. As trial lawyers, we are well aware that no amount can ever truly heal such a tragedy. We will, however, fight tirelessly to ensure that the legal rights of families are protected, and that wrongdoers are held financially responsible for causing a death.

### Proving Your Case

A wrongful death case can come about in a number of ways, including negligence, gross negligence, or a breach of warranty. In a wrongful death case, it will be up to the Plaintiff to establish that one of these factors contributed to the death of a loved one. Unlike other types of cases, a wrongful death case does not stand on its own. Rather, the case will be tied to the way the death occurred, such as an automobile accident or product failure.

### Loss of Companionship

If a loved one has been killed, and you suspect that the death may have been preventable, it is critical that you consult an attorney who is experienced in this area. Like many states, Massachusetts has a Wrongful Death Statute, which determines what loved ones may and may not claim. For example, family members may be able to collect money for loss of companionship- also called loss of consortium- as well as medical expenses, burial costs, and money for any conscious pain and suffering that the decedent experienced.

In Massachusetts, as a factor in your loved one's death, an attorney may be able to not only recover the damages that you and your family deserve, but also hold the person or company that caused the death accountable.
